WINNER NOTIFICATION: Following the random drawing, representatives of the Sponsor will notify the potential winner by email at the email address provided by the entrant when he/she entered the Sweepstakes. If a potential winner does not respond to the notification attempt within the time period specified therein, then such potential winner will be disqualified and an alternate potential winner will be selected from among the remaining eligible entries received.
